TERMS AND CONDITIONS GOVERNING THE USE OF THE CLUB'S FACILITIES

USER'S CONFIRMATIONS

1. As a participant I am aware, understand and accept that in participating in any action watersports activities, including riding in a powerboat, carries an element of danger and risk of injury to myself, which I undertake at my own risk. I hereby release the Club, Members, Instructors, Coaches and equipment from any and all liability of damages, both in law and equity, resulting from personal injuries.
2. That I am in good state of health and free from any injury, medical condition, disease or illness which may be aggravated by participating in watersport activities or which may make it unsuitable for me to participate in such activities.
3. That I will not use the Club's Facilities while under the influence of any drugs, strong medication or alcohol.
4. That I will fully indemnify the Club, its members, agents and employees against any claim brought by any third party for loss, damage, injury or death which has been caused by any action or omission of mine or any act or omission of any child of which I am the lawful parent or guardian or any child whose supervision is wholly or partly my responsibility at the time of the relevant act or omission that would if they had agreed to the same with full capacity to do so amount to a breach of these Terms and Conditions or which amounts to negligence or a willful act or omission.
5. That when accompanying a child or children I will comply and ensure that the child or children comply with safety rules below.
6. I acknowledge that nothing in these Terms and Conditions is intended to avoid liability, on the part of the Club, for personal injury or death caused by the negligence of willful act of its employees or agents.

BASIC SAFETY RULES

All Users' MUST

Let go of the handle and sit down to stop.

Wear the approved equipment – life jacket & wetsuit or shorts at all times.

Remove jewelry.

Inform the member of any medical conditions or injuries.

Refrain from using the Facilities under the influence of drugs or alcohol.

Not swim to the back of the boat unless told to do so, in which case the engine will be turned off, as the PROPELER is under the back of the back of the boat.

Not wrap the ski line around any part of the body whilst in the water.

Comply with the 5 mph speed limit on CWWSC land and avoid using the Facilities in a manner which might endanger others.

Treat the Club's property and the Facilities with respect and care.

This is not intended to be an exhaustive list of safety rules. The Club reserves the right to ask you to leave the Facilities without refund if you break any of the above mentioned rules or behave in a manner which in the opinion of the any authorised person represents a danger or potential danger to yourself or other users.

CHILDREN

All children under the age of 16 years of age must be accompanied by an adult when on the Club's property. The adult must remain on the site for the duration of the child's visit and must supervise them appropriately at all times.

In the case of the participant being under the age of 18 years a person with parental authority must read, understand, accept and sign this agreement on behalf of the participant.
